First of all, please forgive the lateness of this newsletter. We put it off until now for two reasons. First, we've been busy trying everything possible to save Crisp Point Lighthouse. Secondly, we wanted to be able to tell you all of you some very positive news.

The past two months have found Don & others out at Crisp Point physically working on our erosion problems. The Crisp Point Light Historical Society purchased 5' by 10' sand bags at a cost of \$50.00 a bag from Lee Bobiak at Wertheimer Packaging Company, PO Box 33428, Charlotte, NC 28233. We found out about the extra large bags by contacting folks at Cape Hatteras, N.C. Lighthouse. We used Bill Apel's semi-trash pump to fill the sand bags with lake sand.

This effort started the process of positively attacking the erosion. Along with this, other measures included cutting pine trees and with the help of a jeep and large wench trees were cabled out through the water to the remains of the groin pilings and anchored from them to the shore. Don has been fortunate to get some help with this from Bernie Hellstrom and son Andy Hellstrom from Boyne City. They came up for five weekends in a row! Also helping us was John Raths from Saginaw and Tom Faes from Lansing.

Summer Activities

First, a big THANK YOU to Dee Smith who sold our tees and sweatshirts at the Beaver Island Conference for us and Bill Apel who spoke about C.P.L.H.S. for us at the G.L.L.K.A. Lake Michigan Conference.

Bucko Teeple asked me to send the info. packets that I'd previously sent to the Sault tribes and the Bay Mills tribes to him. We received a phone call from Al and one from Bucko about a week later letting us know that the tribes will help financially. What a great day!

At the same time another call came into us from a foundation telling us that an individual wanted to make a contribution to help save the lighthouse (More about this next time).

These have been answers to our prayers and yours. Crisp Point is getting its "miracle."


Every article, every person talked to, every work effort made, each donation, and membership have added up to saving the most endangered lighthouse in the USA

Our contractor, John Lechner from Dafter, MI will haul stone from a quarry in Newberry. He will do a complete contract job of \$42,000 now instead of coming back later. We will be able to pay out what we have and owe him the rest. Each truck load of rock will cost \$800.00. We anticipate approximately 50 loads.

We want you to know that the Road Commission of Luce County will be working with us to complete the last 1/4 mile of County Road 412 to the lighthouse. Please write the road commission and let them know you appreciate their work. Ask them for more county road signs to the lighthouse. Also, letters to the Luce Co. Bd. of Commissioners would be helpful to maintain 412 access to the Luce Co. lighthouse. Please send C.P.L.H.S. a copy of your letters for our records.
